Please note that the Club Recognition Summary is a "recognition" report - not a contribution report. For all constituents associated with a Rotary club, it summarizes Paul Harris Fellow (PHF) Recognition Totals and also Foundation Recognition Points available toward naming a PHF. A constituent can be a Rotarian (donor or non-donor), a non-Rotarian, a business or an organization.

For confidentiality reasons, this report will not display recognition amounts greater than US\$9,000. For Rotary clubs in Europe, Africa, Great Britain, and Ireland, the Club Recognition Summary only includes Rotary club officers, donors and recipients of recognition from The Rotary Foundation.

Below is a glossary to help you better understand the Club Recognition Summary:

Paul Harris Fellow (PHF): An individual who contributes US\$1,000 (or in whose name US\$1,000 is contributed) to the Annual Programs Fund or other approved programs.

Multiple Paul Harris Fellow: A Paul Harris Fellow will receive a new pin for each additional US\$1,000 personally (or in whose name is) contributed beyond his/her original PHF.

100% Rotary Foundation Sustaining Member Club: 100% status is achieved annually when every member of the club has personally contributed US\$100 or more to the Annual Programs Fund by 30 June.

100% Paul Harris Fellow Club: 100% status is achieved when every member of the club is certified as a Paul Harris Fellow. This is a one-time recognition only.

Below is an explanation of Club Recognition Summary columns:

“*”: Indicates constituent is deceased.

Account Number: A Rotarian's Rotary International membership identification number. If the account holder is a non-Rotarian, this is his/her donor account number. An individual should have only one account number. That number will always contain a Rotarian's membership and contribution history. Duplicate accounts should be reported to The Rotary Foundation as outlined above.

“+”: Indicates that the individual is a Benefactor (has contributed \$1,000 to the Permanent Fund or made provisions in their will of at least \$1,000 benefiting The Rotary Foundation).

Name: Listed are all constituents associated with a Rotary Club. Please note that name prefixes and suffixes and titles do not appear on the report, eg.: Mr./Mrs./Ms.; Jr./Sr./III.

Club Member: This column states whether the person is a Rotarian in the Rotary club under which his/her name appears. Y = Active Member. N = Non-Rotarian.

Recognition Amount: The total Paul Harris Fellow recognition credited to an individual's account. Recognition may be achieved with one's personal contributions to the Foundation, a contribution made on behalf of the account holder, or a transfer of Foundation Recognition Points from a Rotary club, district, or another individual. (Note: gifts to the Permanent Fund are not eligible for Paul Harris Fellow recognition and are not included in this column.)

Current PHF Level: Recognition levels are determined based on the following guidelines:

Recognition Amount	PHF Levels	Pin donor or recipient is eligible to wear
1,000 to 1,999.99	PHF	original PHF pin
2,000 to 2,999.99	PHF+1	one sapphire
3,000 to 3,999.99	PHF+2	two sapphires
4,000 to 4,999.99	PHF+3	three sapphires
5,000 to 5,999.99	PHF+4	four sapphires
6,000 to 6,999.99	PHF+5	five sapphires
7,000 to 7,999.99	PHF+6	one ruby
8,000 to 8,999.99	PHF+7	two rubies
9,000 to 9,999.99	PHF+8	three rubies

Paul Harris Fellow recognition is applicable only to individuals. An organization can be recognized upon request with a Certificate of Appreciation when its Recognition Amount reaches \$1,000.

PHF Date: Indicates when the account holder became a Paul Harris Fellow.

Foundation Recognition Points: Awarded in appreciation for contributions an individual personally makes above the initial US\$1,000 but not yet allocated for Paul Harris Fellow recognition. Once an account holder achieves his/her initial Paul Harris Fellow, they may transfer their available Foundation Recognition Points to other individuals to name them Paul Harris Fellows. (Note: gifts to the Permanent Fund are not eligible for Paul Harris Fellow recognition and are not included in this column.)

Last Contribution Date: Displays month and year of most recent contribution.

Last Contribution Designation: Indicates the designation (Program Fund) of most recent contribution.
